Dear Sir/Madam,

With reference to your application dated 11/11/94 I wish to advise you that the Periodical Affiliation of the above-mentioned school with the Board will effect from 1/8/95 to 30/6/96 by the All India/State Secondary School Examinations. The school should abide by all the rules and conditions applicable to affiliated schools, as detailed in the Board's Manual Book for Affiliation of Institutions. The following are, however, specially brought to your attention :

1. The school shall employ only qualified and eligible staff.
2. No new agreement is required with the staff as per norms generally accepted by State Government. A copy of the same to sent to the Board.
3. In the conditions, Pay and allowances and other benefits to the employees of the school shall in no way be less than corresponding categories of employees working in Government schools of the State concerned.
4. The school will help the Board in the smooth conduct of the examinations by placing the necessary staff & accommodation (i.e. Bunks, Messes available in the school premises and facilities as far as possible for holding the examinations) free of charge, if required to do so.
5. The school shall send the ~~1000~~ ⁵⁰⁰ copies of the prospectus by the March each year. A copy of the prospectus form for the same is also enclosed.
6. The school and its staff shall be open for inspection by an officer of the Board or any person authorized by the Board or the State Education Department at any time and the school shall furnish information as may be asked for by the Board from time to time.
7. The rate of tuition and other fees charged shall commensurate with the facilities provided.
8. The admission to the school shall be open to all working on the declaration on the ground of religion, caste or race, place of birth or any of them.
9. No unscrupulous practices should be resorted within the premises of the school or outside its immediate vicinity.
