First of all, Smt. Pratima Sharma, Member Secretary extended a cordial welcome to all members of the School Level Fee Committee (SLFC) and gave their introduction.

Agenda Item no. 1 : Confirmation of minutes of the last meeting held on 21.01.2021. The minutes of the last SLFC meeting was read by the Principal & Member Secretary – Smt. Pratima Sharma and the same was unanimously approved.

Agenda Item no. 2: School Fee for the session 2022-23.

The Principal & Member Secretary – Smt. Pratima Sharma informed the following: -

- (a) The School Fee for the year 2022-23 has already been approved by the School Level Fee Committee (SLFC) in its meeting held on 18.11.2020. The copy of the same was presented to all. (copy attached).
- (b) Last year (2021-22), the Management had approved approx 10% Covid concession in the School Fee approved by the SLFC.


(c) The Principal & Member Secretary put up that the school fee for the session 2022-23 has already been fixed by SLFC in its meeting dated 18.11.2020, if the same is followed then there will be 20% hike in the fee over the fee that has been charged in the session 2021-22. The Principal & Member Secretary proposed that if we charge as per the fee fixed by SLFC then it would be 20% hike on the fee of 2021-2022 therefore we propose that one time 20% hike is not advisable as there is no major challenge on the School with respect to recurring expenditure monthly and thus the hike at a time should only be 10%. For this, the base fee itself should be the fee of 2018-19 and we should make 10% hike on it at a time, the challenges if any will be taken care of by the School Management. The above proposal was appreciated and unanimously approved by the committee.


